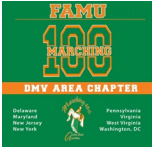
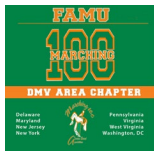
- a) **Changes/Updates:** (Completed before new administration begins)
