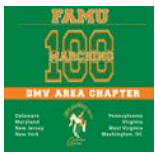

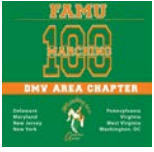

Meeting Minutes

1. **Call to Order (Roll Call). 7:06 PM, by DMV Area Chapter President, Jeremy Green. Attendees were dialed-in on zoom.. The president took the opportunity to welcome everybody to the M100 ABA DMV Area Chapter meeting. He introduced the three (3) special guests:**

 - **Dr. Shelby Chipman - Director of Bands, FAMU**
 - **Dr. Tiffany Sholtz - President of the M100 ABA**
2. **Chapter Initiatives: The DMV Area Chapter Secretary led off the meeting, by talking about the chapter's two (2) major initiatives.**
 - a) **DMV Area Chapter Secretary - Andrea Turk**
 - i. **'Minding Our Business' Campaign. In response to the COVID-19 Pandemic, and the growing need to find other ways to shop to fulfill household and business needs, the DMV Area Chapter started highlighting those Marching 100 Alumni & Associate Band Members who have their own businesses.**

- NO football this fall
- FAMU received performance-based funding this year; it has been two (2) years straight
- On 06 Jan 21, everyone except four (4) of the FAMU Board of Trustees are up for renewal/removal/re-appointment. He emphasized that if we have somebody, that wants to serve on the FAMU Board of Trustees, to send their name(s) to him, so that they can be vetted.

4. 'State' of the FAMU Band Program, from the Director of the FAMU Music Department:

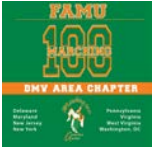
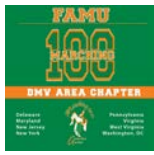
a) Dr. Shelby Chipman.

- He presented a M100 'Recruiting' presentation

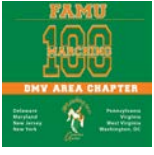
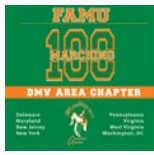

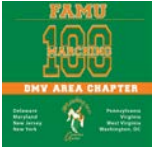
